

**Masonite TrendLive Consumer Sweepstakes**  
**Official Rules 2017**

**1. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**

**2. Eligibility:** Masonite's TrendLive Sweepstakes (the "Sweepstakes") is open to permanent legal U.S. residents (including DC) who are at least twenty-one (21) years of age or older at the time of entry, and who are consumers, licensed remodeling contractors, or builders (**dealers and distributors are not eligible to participate**) in Delaware, Maryland, Massachusetts, Pennsylvania, Tennessee or Virginia. Employees, directors and officers of Masonite ("Sponsor"), Interrupt, Inc. ("Administrator"), and any of their respective affiliates, parents, subsidiary companies, and advertising/promotion agencies (the "Released Parties"), and members of the immediate families of such (spouses, parents, children, and siblings and their respective spouses, regardless of where they reside), and/or those living in the same household, of any of the foregoing, are not eligible. Sweepstakes is subject to all applicable federal, state and local laws. By participating in this Sweepstakes, entrants agree to be bound by these Official Rules and by the interpretations of these Official Rules by Sponsor, and by the decisions of Sponsor, which are final in all matters relating to the Sweepstakes.

**3. Sweepstakes Period/Description:** The Sweepstakes begins at 12:00:00 AM Eastern Time ("ET") on July 25, 2017 and ends at 11:59:59 PM ET on September 22, 2017 (the "Sweepstakes Period"). There is a limit of one (1) entry into the Sweepstakes, per household.

**4. How To Enter:** In order to receive one (1) entry into the Sweepstakes attendance at a Masonite TrendLive event and fill out a form with the required information; your first name, last name, email address, postal code, profession, company name, distributor preference, exterior units purchased annually, interest in the Masonite Preferred Remodeler Program, and statement that you are over 21 years of age and agree to these official rules in the body of the form is required (subject to the above stated limitation, hereinafter an "Entry").

\*All Entries: To be included in the Prize Drawing, as defined below, all: (a) entries, regardless of method, must be received by no later than September 22, 2017 at 11:59 p.m. ET. No incomplete Entry will be accepted. All Entries become the exclusive property of Sponsor and will not be acknowledged. In the event of any dispute concerning the identity of any entrant, the relevant Entry will be deemed submitted by the authorized account holder of the email address provided on the form. The Authorized Account Holder is the natural person who is assigned to the e-mail address by the relevant Internet access provider, online service provider, or other organization responsible for assigning e-mail addresses for the corresponding domain. Any attempt by a participant to obtain more than the allowable Entries by using multiple/different e-mail addresses, identities or any other methods will void all of that participant's entries. **5. Prize Drawing:** After the Sweepstakes Period has ended, there will be three (3) prize drawings ("Prize Drawing") performed, from among all eligible Entries received throughout the Sweepstakes Period, in order to select three (3) potential "Grand Prize" winner and three (3) alternates in the event a winner is disqualified, unreachable or unavailable to claim the Grand Prize. The odds of being selected as a potential prize winner depend upon the total number of eligible Entries received throughout the Sweepstakes Period.

**6. Prizes/Approximate Retail Value ("ARV"):**

Grand Price package detailed herein. Actual value of the prizes may vary depending on fluctuations on current market conditions at time of prize fulfillment, and other factors, and any difference between the stated ARV and the actual value if any, will not be awarded and the value will not exceed the ARV. **8. Prize Winner Notification/Verification:** The potential prize winners are not official winners unless and until Sponsor confirms such. The potential prize winners will be notified by email or phone, in accordance with the email address and/or phone number provided in their Entry (or via another means if applicable and provided), on or about one (1) business day after the Prize Drawing. Administrator will make two (2) attempts to contact the potential prize winners via such method. The potential prize winners will have forty-eight (48) hours from the time of the first notification attempt to respond to Administrator or else Administrator will move on and select/notify an alternate potential prize winner (for the applicable prize). Once contact is made, potential prize winners will be required to sign and return to Sponsor an Affidavit of Acceptance, Eligibility and Liability/Publicity Release (where lawful) as well as a W-9 form, (collectively the "Prize Claim Documents"), within a specified amount of time. Administrator must receive all Prize Claim Documents by the due date indicated during the notification correspondence, or on the Prize Claim Documents. If the potential prize winner fails to respond in the time period specified above, if any Prize Claim Documents are not returned within the number of days specified, if any notification or notification attempt is returned as undeliverable or as an error, or if the potential prize winner declines the prize, then the prize may be forfeited and an alternate potential winner will be notified.
